The role requires the ability to work independently, prioritize tasks, and complete assigned projects in a timely manner. The successful candidate will demonstrate proficiency in carpentry techniques, safe work practices, and attention to detail.

# **ESSENTIAL DUTIES & RESPONSIBILITIES:**

- Perform preventative maintenance to ensure the longevity of building structures.
- Reading and interpreting blueprints and specifications to determine work requirements.
- Building, assembling, and installing wooden structural components, doors, windows, and fixtures.
- Performing locksmithing tasks and assisting in the installation of carpet, flooring, and safety equipment.
- Applying decorative finishes, coordinating construction project activities, and inspecting work sites for repairs and improvements.
- Cleaning work sites, removing worn or damaged materials, and ensuring a safe and clean environment.
- Performing cabinetry and trim work.
- Following established safety rules and regulations.
- Successful candidate must demonstrate a high degree of individual initiative and observe high standards of personal and professional integrity.
