#### **POSITION SUMMARY:**

The School of Education and Speech-Language Pathology at the University of Science and Arts of Oklahoma (USAO) invites applications for a full-time, tenure track position at the Assistant Professor level effective Fall 2025.

#### **RESPONSIBILITIES:**

The primary responsibilities of the individual filling this position will be to teach undergraduate level courses in the Early Childhood Education Program and in the Professional Education core commensurate with qualifications and teaching experience. Teaching duties may include participating in USAO's interdisciplinary, team-taught general education core curriculum depending on the individual's area(s) of expertise. Duties will also include serving as a supervisor for Early Childhood Education teacher candidates while working closely with the Director of the USAO Child Development Center. Other duties include advising Early Childhood Education majors, maintaining office hours, supervising student teachers, serving on committees including the Teacher Education Committee, participating in university activities, participating in recruiting, engaging in professional development/scholarly activity, and assisting with accreditation reports.



#### **OUALIFICATIONS, EDUCATION & EXPERIENCE:**

Candidates with an earned Doctorate in Education are preferred. Minimum qualifications require an earned M.Ed., teacher certification in Early Childhood Education and a minimum of three years of teaching experience in a public school at the PK-3rd grade levels. Candidates with experience in accreditation may receive additional consideration. Selected candidates must demonstrate a high degree of individual initiative and high standards of personal and professional dispositions.

Candidate must be a U.S. citizen or authorized to work in the U.S. and must not require future sponsorship for employment visa status. Candidate must reside within driving distance from USAO (50-mile radius), no exceptions.
